General documents

- Original forms containing the newest tax information (incl. cover sheet)
- Copy of the last tax statement (with attachments: only for new customers)
- Last tax assessment / tax invoices (final tax invoice for the previous year, provisional invoice for the current year)
- Notice of assessment (state and municipal taxes) for the previous year
- Notice of assessment (direct federal taxes) for the previous year

Main documents

Income:

- All salary and wage statements (main and sideline occupation, incl. child benefits and management fees)
- AHV (national insurance) and pension certificate
- Loss of earnings compensation (EO), maternity allowance and unemployment insurance (ALV) certificates

Other documents:

- 3a scheme pension insurance certificate (incl. spouse)
- Professional pension (BVG) insurance certificate [purchasing of pension benefits] (incl. spouse; only if not declared in the salary/wage statement)
- Proofs of child support and alimony payments incl. the address of the recipient: divided in child and spousal support payments (received / made)
- Payment slips for insurance fund (AHV) contributions, paid by you
- Overview of donations made and supporting receipts
- Overview of political party contributions and supporting receipts

For self-employers:

- Balance sheet, income statement and attachments (all signed)
- Statements of assets and liabilities, revenue and expenditures as well as of private withdrawals and contributions for tax-liable entities with simplified accounting
- Statements of write-offs or provisions
- Form for stating liquidation gains upon discontinuation of self-employment (if applicable)

- Property maintenance bills (incl. land taxes, building insurance, chimney sweeping, replacement costs etc.): details and payment slips for each property
- Copy of the official market value estimate for each property; copies of all purchase or sale contracts

Debt directory

- Debt and mortgage interest statements as of 31 Dec. 2017
- Details of other personal debts and interest rates as of 31 Dec. 2017 (e.g., outstanding invoices as of 31 Dec. 2017)

Insurance directory / Healthcare and emergency expenses / Disability costs

- Overview of annual health insurance premiums and expenses of 2017
- Life insurance and private accident insurance premiums
- Details of health insurance premiums (please provide a copy of 2017 insurance policy if possible)
- Receipt for health insurance premium reductions of 2017
- Details and payment slips for healthcare expenses (health service deductibles, dental or optical bills etc.)
